For many years, Her Majesty the Queen has recognised and honoured members of the Britain's minority communities for their contribution to British society. We congratulate those honoured, and acknowledge others who have made a special contribution to the welfare, prosperity and inclusion of minority communities within British Society.

Since our inaugural awards in 2001, the position of the British Muslim community in particular has continued to mature as an increasingly integral part of mainstream British society. To reflect this tremendous achievement, in 2010 we renamed as *The British Community Honours Awards* and extended the Community Awards to further recognise those who work to improve the welfare and integration of minority and ethnic communities within wider British society. This was a wonderful milestone, reflecting the contribution minority communities play as integral parts of the fabric of modern British mainstream society.

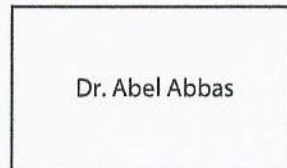
This year, the *British Community Honours Awards* is donating to the National Osteoporosis Society, Tusk Trust, Save The Children, Cancer Research UK.



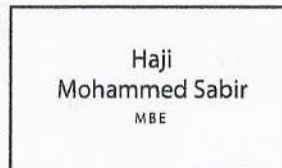

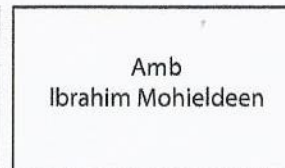
